Minutes of Okeechobee County School Board Workshop October 22, 2013

The Okeechobee County School Board met in workshop session on the above date with the following members present: Chairman David Williams, Vice Chairman India Riedel, Joe Arnold, Gay Carlton, and Malissa Morgan. Also present were Ken Kenworthy, Superintendent of Schools, and Tom Conely, School Board Attorney.

Chairman Williams called the meeting to order. Tom Conely, School Board Attorney, opened the meeting with prayer, and Chairman Williams led those present in the pledge of allegiance.

Superintendent Kenworthy reviewed an expanded agenda which was provided for the Board. He asked if there were any items that the Board would like to add or anything in particular that they would like to discuss during the workshop. Member Joe Arnold asked if the goals that were not met last year are included on this year's Strategic Plan with possibly higher standards that would set up the District for failure on goals this year. Superintendent Kenworthy responded that some goals were set higher and some were not, but that all would be reviewed during the workshop to determine if they are appropriate. He explained that District Administrators and Principals met over the course of several months and examined large amounts of data to develop this year's Strategic Plan. The overall objective in developing the plan was to increase student achievement through goals that are attainable.

Superintendent Kenworthy reviewed the Vision, Mission, and Core Values, and asked the Board to state the qualities or characteristics that they want for the District. The responses from the Board included:

- Students should see gains.
- Is more than a year's gain in a year's time expected?
- It is important that students read on grade level by grade 3. Long term goals will be much more easily met if students read on grade level, most importantly by grade 3.
- Would like to see the dropout rate reduced and students remain in school until they are career or college ready.
- Would like to see 100% graduation rate.
- It is important for teachers to be highly qualified. The District needs to provide resources for teachers to stay highly qualified.
- Students should be well-rounded, good citizens when they graduate.
- Parent and community involvement is very important as is teacher morale.

Superintendent Kenworthy asked the Board if the District's Vision, Mission, and Core Values accurately reflect their goals for the District.
