Amendment of Board Policy 3.29+ Domestic Security

- I. This policy provides for a domestic security plan for the District.
- II. Proposed revisions of this policy is based on recommendations from the Office of Safe Schools. The Florida Department of Education is required to review each District's Threat Assessment Procedure. These changes were recommended as a result of that review.
- III. Legal authority for this policy is F.S. 1001.41 and 1001.42. Laws implemented are 1001.43, 1001.51, 1001.54, 1006.07, 1006.08, 1006.09, 1006.21, 1013.13, F.S.; State Board of Education Rules: 6A-1.0403 and 6A-3.0171.
- IV. This policy amendment will not affect individuals from an economic standpoint.

<u>Amendment of Board Policy 4.30</u> <u>Student Clubs and Organization</u>

- I. This policy provides guidelines and requirements for student clubs.
- II. The proposed amendment updates language to conform to current practice.
- III. Legal authority for this policy is F.S. 1001.41, 1001.42, 1001.43, 1006.07, 1006.09, 1006.135, and 1006.14.
- IV. This policy amendment will not affect individuals from an economic standpoint.

Adoption of Board Policy 8.05*+ Safety

- I. This policy defines the School Board's commitment to protecting the safety of its students and school community.
- II. The proposed policy is recommended based on State Board of Education Rule 6A-1.0017.
- III. Legal authority for this policy is F.S. 943.082, 1001.41, 1001.42, 1002.20, 1006.63. Laws implemented are F.S. 316.614, 773.06, 1001.43, 1006.062(3), 1006.07. State Board of Education Rule: 6A-1.0017.
- IV. This policy amendment will not affect individuals from an economic standpoint.

Amendment of Board Policy 8.11* Emergency Evacuation Drills

- I. This policy provides guidelines and requirements for emergency evacuation drills.
- II. The proposed amendment identifies the specific requirements for the number of drills to be held in accordance with F.S. 1006.07.
