The Okeechobee County School Board met in regular session on the above date with the following members present: Chairman Joe Arnold, Vice Chairman Gay Carlton, Malissa Morgan, India Riedel, and David Williams. Also present were Ken Kenworthy, Superintendent of Schools, and Tom Conely, School Board Attorney.

Chairman Arnold called the meeting to order. Tom Conely, School Board Attorney, opened the meeting with prayer, and Chairman Arnold led the Pledge of Allegiance.

The Board and Superintendent recognized *Michael Daniel*, for being selected as a 2014 Sunshine State Scholar representing Okeechobee High School. Wendy Reister, Sponsor, was also recognized.

The Board and Superintendent recognized *Tamea Allen, Jessica Mond,* and *Julia Weldon,* for qualifying to represent Okeechobee High School at the State Weight Lifting competition. Coach Tyrone Smith was also recognized.

The Board and Superintendent recognized *Tiffany Bowers* for representing Okeechobee High School and placing 3rd in the State in Girls Wresting. Coach Bruce Jahner was also recognized.

The Board and Superintendent recognized *Cory Vickers* for qualifying to represent Okeechobee High School at the State Wrestling competition. Coach Bruce Jahner was also recognized.

The Board and Superintendent recognized *Calberth Baul*, Custodian at Okeechobee High School for his retirement and 15 years of service.

On a motion by Gay Carlton, seconded by India Riedel, the Board voted unanimously to approve the Minutes of the meeting held on February 11, 2014.

Chairman Arnold recognized the following individuals who submitted requests to address the Board regarding valedictorian and salutatorian selection:

- Steve Moreland, Parent
- Zane Moreland, Student
- Irfan Chaudhary, Student
- Dr. Muhammed Chaudhary, Parent

The speakers questioned the fairness of the current system by which points are given for the number and types of courses to determine the valedictorian and salutatorian of the graduating class. Both students addressing the School Board received A's in all courses they have taken and yet were not named as valedictorian or salutatorian. According to the speakers, this is because the current point system places more emphasis on the number of courses taken than on the difficulty of the courses taken. They stated that it is unfair to students who take more rigorous courses and maintain a 4.0. They stated that the point system is outdated, a B is counted as only one (1) point less than an A, and there are many other flaws in the system. Students decide which courses to take based on the advice of their guidance counselors and may not understand how the courses will affect their standing in the valedictorian and salutatorian selection. Both students and their parents asked the Board to reconsider the process of selection for this year's valedictorian and salutatorian. The students stated that they deserve the top ranking and should have been considered for the honor based on the rigor of courses they took and the fact that they both maintained a straight 4.0 GPA.

Superintendent Kenworthy complimented the students for receiving a perfect 4.0 GPA and said that not many students were able to achieve such an accomplishment. He explained that selection of valedictorian and salutatorian is based upon a quality point system. Quality points are assigned to honors, advanced placement and dual enrollment classes. Five quality points are awarded to students earning an "A," four quality points are awarded for a "B," and so forth. At the end of the first semester of the senior year, the two students with the most quality points receive the designations. He stated that this

system has been in place since 1998, and may need to be examined since there are more courses being offered in dual enrollment and advanced placement. Superintendent Kenworthy stated that although the two students presenting tonight did receive all "A"s and a perfect 4.0 GPA, the fact that the other students took more courses caused them to be awarded additional quality points. Current policy as published in the Student Progression Plan and the Parent Guide were followed in the designation of the valedictorian and salutatorian.

After lengthy discussion by the Board and Superintendent the Board agreed that the students already designated as valedictorian and salutatorian should be named co-valedictorians along with Zane Moreland and Irfan Chaudhary, therefore having four (4) co-valedictorians and no salutatorian for the 2014 graduating class. The Board members commended both students for maintaining straight A's in all their courses.

India Riedel made a motion that all four students with the highest quality points and GPA should be named co-valedictorians. The motion was seconded by David Williams, and the Board voted unanimously to approve the motion as stated.

Further, the Superintendent and Board discussed the possibility of changing to a cum laude system of determining academic honors for graduation, as some districts are doing. He reported that both his student advisory group and the high school student council have indicated that they would like to move away from the valedictorian and salutatorian system. While the current system honors the top two students academically, a cum laude system would allow more students to be honored for academic achievement. Superintendent Kenworthy stated that the method of selection for valedictorian/salutatorian is a part of the Student Progression Plan, which requires public notice before any changes can be made to it. The Board suggested that a workshop for the Board to review the Student Progression Plan would be appropriate at this time and requested that Superintendent Kenworthy recommend the earliest possible dates at the regular April Board meeting.

Chairman Arnold asked if the Superintendent or Board members had any changes, additions, or deletions to the *Items for Action*. Superintendent Kenworthy requested that Item L., *Separation Agreement and General Release*, be added to the agenda; and as a result of adding this item, Superintendent Kenworthy requested that Item VII., *Hearing*, be withdrawn. On a motion by India Riedel, seconded by Gay Carlton, the Board voted unanimously to add Item L. to the *Items for Action* and withdraw Item VII., *Hearing*.

The School Board of Okeechobee County, Florida, hereby certifies that pursuant to a legal notice, a meeting for public hearing was held in Room 303 of the School Board Administrative Office, 700 S.W. 2nd Avenue, at 6:00 p.m. in the City of Okeechobee on the 11thth day of March, 2014, for the purpose of discussing adoption of Board Policy 5.321 <u>Bullying and Harassment</u>.

The Board further certifies that it remained in session until 7:15 p.m. and there appeared no one at said hearing to oppose or discuss this policy change.

On the recommendation of Superintendent Kenworthy and a motion by Gay Carlton, seconded by Malissa Morgan, the Board voted unanimously to approve amendment of School Board Policy 5.321 <u>Bullying and Harassment</u>. The policy amendment adds language regarding cyberbullying and cyberstalking in accordance with changes made to Florida Statute 1006.147. Advertisement of the intent to amend Policy 5.321 was approved by the School Board on February 11, 2014, and legally advertised to the public on February 12, 2014, as required by Chapter 120, Administrative Procedures Act, Florida Statutes. Superintendent Kenworthy stated that he received no comments or questions from the public regarding the proposed amendment.

On the recommendation of Superintendent Kenworthy and a motion by Malissa Morgan, seconded by Gay Carlton, the Board voted unanimously to approve advertisement to amend Board Policy 2.20 <u>Board</u> <u>Meetings</u> to bring the policy into agreement with current statutes and practice regarding public speakers at School Board meetings. Superintendent Kenworthy commented that the legislative intent of this policy is to provide everyone an opportunity to speak at public meetings if they request to do so.

On the recommendation of Superintendent Kenworthy and a motion by India Riedel, seconded by Malissa Morgan, the Board voted unanimously to approve advertisement to amend Board Policy 3.45 <u>Background</u> <u>Screening for Contractors</u> to bring the policy into agreement with current statutes regarding issuance of state ID badges for contractors. Superintendent Kenworthy commented that Senator Grimsley sponsored this bill so that one statewide badge could be issued to contractors who work in multiple counties.

On the recommendation of Superintendent Kenworthy and a motion by Malissa Morgan, seconded by Gay Carlton, the Board voted unanimously to approve advertisement to amend Board Policy 3.70 <u>Flag</u> <u>Display and Pledge</u> to bring the policy into agreement with current statutes regarding display of the U.S. flag and the Florida flag. Superintendent Kenworthy commented that the proposed amendment contains minor changes in addition to requiring that all U.S. flags display in schools and on school property must be made in the U.S.A.

On the recommendation of Superintendent Kenworthy and a motion by India Riedel, seconded by Gay Carlton, the Board voted unanimously to approve advertisement to amend Board Policy 6.113 <u>Responsibilities of School Bus Operators</u> to bring the policy into agreement with current statutes banning texting while driving and reducing heavy duty idling.

On the recommendation of Superintendent Kenworthy and a motion by Malissa Morgan, seconded by India Riedel, the Board voted unanimously to approve advertisement to amend Board Policy 6.56 <u>Professional Ethics</u> to bring the policy into agreement with current statutes regarding newly required ethics training for the Superintendent and School Board members. Board Member India Riedel asked the Superintendent what activities are done with staff to refresh and review their ethics training. Superintendent Kenworthy responded that a PowerPoint presentation for ethics training has been developed. Employees view the presentation, which includes a 10-question quiz at the end. When an employee completes the training, a certificate is placed in his/her personnel file. Ms. Riedel stated that Board and Superintendent are required to complete ethics training yearly and that it is important for the training to be provided to staff members.

On the recommendation of Superintendent Kenworthy and a motion by Gay Carlton, seconded by David Williams, the Board voted unanimously to approve advertisement to amend Board Policy 8.23 <u>Transporting Students in Private Vehicles</u> to bring the policy into agreement with current statutes banning of texting while driving.

On the recommendation of Superintendent Kenworthy and a motion by Gay Carlton, seconded by Malissa Morgan, the Board voted unanimously to approve advertisement to amend Board Policy 8.30 <u>Automotive</u> <u>Equipment</u> to bring the policy into agreement with current statutes banning texting while driving and reducing heavy duty idling.

On the recommendation of Superintendent Kenworthy and a motion by David Williams, seconded by India Riedel, the Board voted unanimously to accept the Internal Funds Financial Statement/Audit Report for all schools for the period ending June 30, 2013, and ordered it filed as part of public record. Superintendent Kenworthy commented that no material weaknesses were reported and that six (6) schools had perfect audits with no findings. The Board commended school staff and bookkeepers for receiving good audit reports.

On the recommendation of Superintendent Kenworthy and a motion by Gay Carlton, seconded by David Williams, the Board voted unanimously to approve an agreement with the District School Board of Putnam County on behalf of the North East Florida Educational Consortium (NEFEC) to provide Virtual Instruction Program Services effective February 5, 2014, through July 30, 2014. Superintendent Kenworthy commented that this agreement will allow eligible Okeechobee Students to participate in online instruction through NEFEC, a facilitator of a virtual instruction program for 6th-12th grade students. The agreement will allow the District to recover some of the FTE for students enrolled online through NEFEC.

On the recommendation of Superintendent Kenworthy and a motion by India Riedel, seconded by Malissa Morgan, the Board voted unanimously to approve the 2014-15 Instructional Calendar as follows:

- A. Superintendent
 - Superintendent Kenworthy discussed possible dates for the Board's next tour of schools. The Board members decided on the following schedule:

<u>Tuesday, April 8, 2014</u> 8:30 a.m. – Seminole Elementary School 9:30 a.m. – North Elementary School 10:30 a.m. – Yearling Middle School

- B. School Board Members
 - Malissa Morgan asked Superintendent Kenworthy if he obtained any information on random drug testing of employees. Superintendent Kenworthy responded that he surveyed all the districts in Florida and found that 6 districts responded that they conduct random drug testing of employees. After calling the six districts, it was found that only three (3) districts were possibly doing random testing of employees. Of those three districts, Superintendent Kenworthy has had further contact at this point with one district which is Washington County. The Washington County written policy was provided for the Board. Washington County Schools tests 50% of employees who perform safety sensitive functions and 10% of each of other work groups on a quarterly basis. Superintendent Kenworthy stated that there are two cases that give him cause for concern. Governor Scott was challenged on testing of welfare/government assistance recipients and also on random drug testing of State employees. He was struck down in both cases. Ms. Morgan said that although there is emphasis on new hires for drug testing, the District would do well to seek training for all employees, especially administrators, to recognize signs of drug and alcohol abuse to determine if there is reasonable suspicion of impairment. Superintendent Kenworthy reported that there is training available from USA Mobile Drug Testing (the contractor used for random student drug testing) on recognizing reasonable suspicion.
 - Malissa Morgan reported that she attended the Florida Flywheelers Annual Show in February. The tractor project that she and her husband sponsored came to an end, and the project should receive a check for \$18,000.00 in April or May. Ms. Morgan reported that the Flywheelers are anxious for another group project from Okeechobee.
 - Gay Carlton announced that she will not run for another term on the School Board when her term expires this November. Chairman Arnold thanked Ms. Carlton for her service on the School Board.
 - India Riedel stated that in light of recent incidents in the school district and the community, addressing the problem of drug/alcohol abuse should be ongoing. She encouraged the Superintendent to pursue a means to effect some change in staff members who may need help regardless of case law.
 - Joe Arnold commented that he has looked into the subject of random drug testing for government employees and found that the 4th Amendment to the U.S. Constitution is for government, not for private business, and that government can only do what has been challenged. He stated that he believes if the District moves forward with random drug testing for employees, that a federal law suit against the District could be quite possible.
 - Joe Arnold reported that Okeechobee has two (2) students going to the International Science Fair this year. He also reminded those present that the Livestock Show is taking place this weekend.

- C. Board Attorney
 - Tom Conely noted that the Washington County policy on random drug testing contains a caveat that states, "unless prohibited by law or other governing documents that may supersede the policy." Mr. Conely advised the Board to be very careful going forward on random drug testing of employees. Superintendent Kenworthy reported that the last student drug testing found two (2) positives for marijuana. He also stated that students are self-reporting a higher rate of usage. Malissa Morgan stated that she believes awareness training is paramount and will have a more immediate effect than random drug testing.

D. Public - None

There being no further business to discuss, on a motion by Gay Carlton, seconded by David Williams, the Board adjourned at 7:15 p.m. The next regular meeting of the School Board is scheduled for 6:00 p.m. on Tuesday, April 8, 2014, at 700 S.W. 2nd Avenue, Okeechobee, Florida.
