The remaining 20% could be used to increase the salaries of classroom teachers and other instructional staff who did not receive at least a 2% raise from the 80%. All instructional employees received at least a \$925 raise from the Teacher Salary allocation. Those making less than the new base received a raise ranging from \$1,325-\$4,125. It is important to note that the District contributed additional General Fund dollars to ensure that every eligible employee received a raise of at least \$2,125. The plan was due December 1, but Superintendent Kenworthy notified them that it was going to be presented to the Board tonight for ratification. The final plan can now be submitted to DOE for approval.

VII. Information Items

A. SUPERINTENDENT -

- Mr. Kenworthy announced the Spring Plan is due to DOE on December 15. The Plan does not need Board approval. The Plan includes the requirement of five-day brick and mortar schooling, full services to all students including ELL and students with disabilities, progress monitoring and Professional Development in grade level standards and to meet the technology needs of teachers. Mr. Kenworthy spoke to Chancellor Olivia today and several districts are going to eliminate Option 2 and continue with Virtual Learning especially for students with a medical condition. The Executive Order requires that parents/guardians receive a written notice if their student is at risk of failing. The District will continue to offer a modified Option 2 for students that are quarantined or excluded. The modified Option 2 will move from synchronous to an asynchronous model. The model may include recorded lessons and a days delay in presentation. The plan will also include enhanced outreach addressing truancy and DNEs.
- Mr. Kenworthy reminded Board members to submit their Ethics certificate to Sharon before the end of December.
- The Superintendent reminded Board members that schools will be closed for Winter Break, December 21, to January 4, as a teacher's workday. December 18 was converted to a full day of school due to Tropical Storm Eta.

- The next Board meeting is Tuesday, January 19, a special date due to the holiday break.
- Mr. Kenworthy asked Board members if they would like to continue Board meetings with zoom or to invite everyone back in person only. Member Arnold stated that he would like to continue with zoom and to invite participants to attend as well, give options. Vice Chairman Jahner agreed.

B. SCHOOL BOARD MEMBERS -

Vice Chairman Jahner asked that the District look at the salary step plan of other Districts.
The local plan is very confusing; we might find something that appeals to our District.
Member Arnold agreed that it is confusing and would like to see the compression spaced out with time. Merry Christmas and Happy New Year.

D. PUBLIC -

- Campus President Russ Brown, Indian River State College, Dixon-Hendry Campus, asked for the opportunity to update the Board and share appreciation for the Districts relationship with the college. Okeechobee has the most participation and success in dual enrollment in the four county area. Campus President Brown stated that ten years ago, there were fewer than 80 participants, last year there were over 500 students in the program. In 2018-19 twenty-two students and in 2019-20 twenty students completed high school with an AA degree. Mr. Brown thanked members for their support of dual enrollment and the Grow Your Own Educators program. The high school and the college are within a half-mile of each other, but IRSC provides access and uses high school instructors as adjunct instructors. This does not happen in other areas. The District is very fortunate to have this relationship and Mr. Brown and his staff are very much appreciated. The Grow Our Own program is expanding as it is difficult to recruit teachers, but it starts with dual enrollment. Students can do the coursework and the District can hire them once they come of age to substitute. The students can earn money and credits towards their bachelor's degree. This is a great incentive for them to continue and the District can offer them a job even before they graduate from IRSC. Chairman Riedel thanked Mr. Brown and IRSC.
- Mr. Conely distributed and read into record an e-mailed public comment from a parent, Ashley Johnson. Mr. Conely stated that some of the questions ask by the parent were answered in Mr. Kenworthy's presentation.
