- * (1) Organize, file and maintain ELL records using established guidelines and procedures.

- * (4) Cover teachers' classes, if needed, to allow teachers to attend the required ELL Review meetings.
- * (5) Ability to work with other schools, departments, and staff to review placement and identify the need for an ELL committee meeting.
- * (6) Assist guidance counselor with duties required for meeting the needs of ELL students.
- * (7) Demonstrate initiative in the performance of assigned responsibilities.
- * (8) Coordinate and assist in the administration of State mandated ELL assessments.
