III. <u>Presentation</u>......Sodexo

Ron Gomez, Director of Business Development, provided a power point presentation and short video about the food service program. Mr. Gomez shared statistics from Wakulla and Hendry County Schools showing the increased participation in breakfast and lunch programs. Ron spoke about what drives participation: taste, quality, variety and a warm, welcoming environment. He spoke about three models: Sodexo employees, combined model and School District Employees. Part of the program could include the opportunity for District employees to transition to Sodexo after retiring from the District. Mr. Gomez said that Sodeo provides a package with pay, hours and benefits equal to or better than employees currently receive. Sodexo also provides training, resource library and online training.

Member Morgan asked about the one year transition guarantee and training, if the District retains employees. The one year guarantee is reviewed each year and the same level of training is offered to District employees.

Member Arnold asked about negatives or challenges. Mr. Gomez stated that some of the challenges include culture consistency, branding, and level of identity. Input from long time employees is important, take lessons learned and improve.

Chairman Holcomb asked about the freshness component, made to order products and employee benefits. Mr. Gomez said about 50% of middle and high school meals are made to order. A Chef and Dieticians offer guidance with recipes, menus and planning fresh and nutritious meals. Sodexo offers a 401K for employees, with a match of up to 6% of employee contributions. The traditional contract is for five years, with four one-year renewals.

Member Morgan asked about purchased equipment staying with the District, if the contract ends prior to five years. She also stated that she would be interested in visiting schools that have their employees and a school that Sodexo has transitioned the employees. Mr. Gomez stated that if they leave before the contract ends, Sodexo could take equipment or a depreciated cost would be

determined and the District could purchase the equipment. Mr. Gomez said he would be happy to arrange school cafeteria visits.

Chairman Holcomb asked if Soxedo pays for the branding, remodeling, uniforms and training. Mr. Gomez said yes.
