Amendment of Board Policy 2.12 Special Committees of the School Board

- I. This policy explains special committees.

Amendment of Board Policy 2.20*+ School Board Governance and Organization

- I. This policy provides procedures for conducting School Board meetings.
- II. The proposed amendment reflects current practice.

<u>Amendment of Board Policy 2.40*+ School Improvement, Education Accountability</u> <u>and School Advisory Council</u>
